



2024-25 REGISTRATION & ENROLLMENT CONTRACT

General Info	Enrolled students at <i>Music Academy of Greater Milwaukee</i> will have the opportunity to participate in 30 weekly classes (15 during each semester). Please log on to www.PlayOrSing.com for current information regarding tuition, class schedules, locations, calendars, and much more.
Registration & Enrollment	<p>To Register: Parent must submit a completed registration form for each child. Parent will then receive an invoice from <i>Music Academy of Greater Milwaukee</i>. (Registered students (only) may attend the first day of classes for no charge or obligation.) Students are only officially enrolled in a class once the payment is received in full (credit-card PayPal cash check). See <i>Enrollment page on our website for deadlines, etc.</i></p> <p>In some cases, parents may enroll their child(ren) mid-semester (for the normal tuition amount) at the discretion of <i>Music Academy of Greater Milwaukee</i>.</p> <p>Tuition payments and other fees will not be refunded, installed, reduced, or prorated. Classes or lessons missed due to student absences will not be made up or refunded.</p>
Private Instruction	During Summer Session, private music instruction is offered at all locations. <i>Please refer to the Summer Session page on our website for details.</i>
Classes and Expectations	<p>We will make every effort to start and end each class on time. Students are required to follow class procedures, to show respect for other children, all adults, all music equipment, and our building/hosts so that everyone can experience enjoyable, safe, and productive sessions. Students are expected to practice their assignments <u>daily</u>. All students (except those in “Mini-Maestros” and “Musica Primaria”) are to turn in completed practice cards each week. Class participation is reserved only for enrolled (paid) Homeschool & Virtual School students. Parents of enrolled students may occasionally observe classes if space is available. <i>Non-enrolled families are not permitted to be in the buildings during our class days.</i> Parents are to keep their children at home if they or their children experience flu symptoms, fever, respiratory infection, etc. This supports the well-being of the other families.</p>
Performances	We present 2 concerts (featuring all students) per academic year. (Details are posted on our website.) In addition, students at each location have the opportunity to perform in 3 informal recitals (which are held during normal class days/hours). Classes are also held as usual on those days.
Equipment & Lesson Materials	<p><i>Music Academy of Greater Milwaukee</i> does not rent or sell instruments (other than recorders). We can advise and recommend area stores for this purpose. Related information is posted on our website.</p> <p>Students/parents are responsible for the upkeep/repair of instruments, and for purchasing recommended books/supplies.</p> <p>Most books (and some supplies) can be purchased from <i>Music Academy of Greater Milwaukee</i>.</p>
Inclement Weather & Cancelations	We will notify parents via email and post a message on our website if winter weather or other circumstances require us to cancel classes on a particular day. As always, we will make every effort to “make up” canceled class days by adding an additional day to the end of the academic year. In cases of “Acts of God” or “Force Majeure,” at least some “make up” classes/lessons may be held via “online video/audio exchange,” “video calls,” or “audio calls.” Families unwilling or unable to participate in make-up sessions (whether in-person or online) will not be given full or partial refunds. In the case of any future government-imposed gathering limit, we will adjust our class schedule and/or sub-divide classes in order to continue to meet in person.
Parental Supervision Requirement	<p>Due to liability, health, and safety concerns, parents are to wait for their children in the waiting or classroom areas. Parents are to never leave an academy site without their children.</p> <p>Parents are responsible for the direct supervision of their children whenever their children are not participating in a class.</p>
Space Usage Agreements	We have permission to use <u>only</u> the designated classroom/waiting areas, restrooms, and parking lot/sidewalk areas at our academy sites (not unpaved outdoor areas). These areas are designated in the rental contracts we have with the churches that own the buildings that we utilize. <i>Children and adults associated with the Music Academy should not enter areas of the church buildings/properties that have not been assigned to us by contract.</i>

**MUSIC ACADEMY OF GREATER MILWAUKEE****Release, Indemnification, and Hold Harmless Agreement
2024-25 Fall & Spring Semesters**

In consideration of participation by the undersigned (“Registrant”) in the *Music Academy of Greater Milwaukee*, I, the parent or legally appointed guardian of Registrant hereby releases, on behalf of myself and on behalf of the Registrant, *Music Academy of Greater Milwaukee*, *Still Waters Community Church*, *Point of Grace Community Church*, *New Vision Brethren-Christ Church*, *Layton Avenue Baptist Church*, plus any additional churches or organizations providing classroom or waiting facilities, their affiliates, employees, and agents, and *Wisconsin Lutheran College*, plus any other practice or performance venue (all of the foregoing are the “Released Parties”), from any responsibility or liability in the event that the Registrant or any family members of the Registrant incur any injury, illness (whether due to epidemics, pandemics, or other sources), or damage to personal property while participating in the program or at the concert venues, regardless of whether such injury, illness or damage is the result of the negligence of the Released Parties or not, except that this release shall not apply to injury, illness, or damage arising from the intentional conduct of the Released Parties. The parent or legally appointed guardian of Registrant acknowledges and affirms that this release has been negotiated by and between the parties, and is reasonable to the Registrant. The parent or legally appointed guardian of the Registrant acknowledges that certain activities related to participation in the Music Academy of Greater Milwaukee present risks that may include slips or falls while using the facilities, misuse of equipment, failure of equipment, or acts or omissions of other persons, including other participants and employees and agents of *Music Academy of Greater Milwaukee*.

The parent or legally appointed guardian of Registrant hereby releases, holds harmless, and indemnifies the Released Parties against any and all liability costs and expenses arising in any way as a result of the Registrant’s participation in the Music Academy of Greater Milwaukee. The person submitting the registration on behalf of Registrant, whether electronically or by printed copy, warrants and represents that he or she is the parent or legal guardian of Registrant and has the authority to enter into this release, hold harmless and indemnification agreement on behalf of the Registrant and all family members of Registrant.

This Release, Indemnification, and Hold Harmless Agreement (“Agreement”) is governed by the substantive laws of the State of Wisconsin. This Agreement is intended to be binding on all persons submitting the registration, the minor Registrant, and their respective successors, heirs, personal representatives, administrators and family members. If any part of this Agreement is deemed by a court of competent jurisdiction to be invalid or unenforceable, the remaining provisions shall nevertheless be in full force and effect. This Agreement will govern all participation by Registrant in the activities of *Music Academy of Greater Milwaukee* until withdrawn or replaced by a subsequent agreement which will then apply thereafter. Because the Agreement is a bargained and critical element of the agreement by *Music Academy of Greater Milwaukee* to provide instruction to Registrant, any withdrawal of the Agreement by Registrant (or Registrant’s parent or legally appointed guardian) will result in the termination of the services provided by *Music Academy of Greater Milwaukee*.

It is understood and agreed that *Music Academy of Greater Milwaukee* assumes no responsibility or liability for any of my children at any time.

I understand that any student, parent, guardian, or other family member displaying behavior that is disrespectful to others, disruptive to the education or well-being of others, or disruptive to the effective operation of the Music Academy may cause any or all students from that family to be dismissed from the program without refund.
5. I give permission for my child(ren) to be photographed, videotaped, or recorded without compensation for use in any *Music Academy of Greater Milwaukee* published material or on the academy website, with the explicit understanding that my child will not be identified by name.
