



SUMMER SESSION 2024 REGISTRATION & ENROLLMENT CONTRACT

Semester	Each summer, enrolled students will attend up to 9 (7 paid plus 2 make-up/bonus) weekly lessons or classes. Please log on to www.PlayOrSing.com for current information regarding tuition, lesson time openings, class schedules, locations, calendars, and more.
Registration & Enrollment	To enroll a child, a parent must submit a completed registration form (one for each child) and payment (in full – credit card, PayPal, cash or check) before the first lesson or class of the summer. <i>Please make checks payable to Music Academy of Greater Milwaukee.</i> Tuition payments cannot be refunded, installed, or prorated.
Locations & Schedules	Lessons and classes are held weekly at each of our 4 <i>Music Academy</i> locations. Please log on to www.PlayOrSing.com for more information.
Classes	<p>We will make every effort to start and end each lesson or class on time. We require our students to follow class procedures. We also expect students to show respect for other children, all adults, all music equipment, and our building/hosts so that everyone can experience enjoyable, safe, and productive sessions.</p> <p>We have rental agreements with 4 Wisconsin churches, and have permission to use the classroom areas, the waiting areas, the restrooms, and the parking lots. We do <u>not</u> have permission to use other areas at this time.</p> <p>Parents will wait for their children in the waiting areas, and <u>should not leave the building without their children</u>. When not involved in a class, <u>each child is under his/her parent's direct supervision</u>. Parents may observe lessons or classes if space is available in the classroom area. Class participation, however, is reserved for the children only.</p> <p>Children, when not in class, must wait in a <u>waiting area</u>. Children may wait outside under parent supervision, but must stay on paved or sidewalk areas only.</p>
Concerts	Concerts and recitals are presented only during the Fall & Spring Semesters. However, Summer Session students may perform their summer material at a Fall Semester recital.
Lesson Materials	<i>Music Academy of Greater Milwaukee</i> does not rent or sell instruments (other than recorders), but can advise and recommend area stores for this purpose. Students/parents are responsible for the upkeep/repair of instruments and are responsible for purchasing recommended books/supplies. Books and some supplies can be purchased at class.
Cancellations	If inclement weather or other circumstances require us to cancel lessons/classes on a particular day, we will make up those lessons/classes one week after the last scheduled date of Summer Session. Classes or lessons missed due to student absences cannot be made up (outside of the posted dates) or refunded. In cases of "Acts of God," "Force Majeure," or government ordered shut-downs, at least some classes/lessons may be held via "online video/audio exchange," "video calls," or "audio calls." Families unwilling or unable to participate in these sessions will not be given full or partial refunds.
